Thirty-two of those tornados occurred in the NWS Chicago region. When events like this hit hard and fast, they create many struggles, not only for field personnel, but also for the dispatch. Call volumes more than tripled during the storm, loss of communications, outdoor warning system issues and response times were extended due to the weather conditions. The biggest challenge was the "loss" of the radio system, which left very limited, almost none, communication abilities with field personnel.
